

## SHIPPING INSTRUCTIONS

**IMPORTANT:** Ship the specimen on the same day or the next calendar day of collection. Do not freeze or chill after collection to prevent hemolysis. Hemolyzed samples or delayed shipment will result in sample rejection.

**Call FedEx at 1-800-463-3339 to Schedule Your Free Pickup**

1. When the automated greeting begins say, "Schedule a pickup."
2. Advise Customer Service this is a RETURN SHIPMENT and provide them with the RETURN TRACKING NUMBER which can be found on your return label.
3. The Kit Box can also be dropped off at a FedEx Office or FedEx Drop Box.
4. Mark the box on the FedEx Clinical Pak Mailer stating: 'Exempt Human Specimen'.

OR RESULT IN A REJECTED SAMPLE


**NOTE:** Please review all instructions and collection kit components before starting your sample collection. *Sample must be kept at room temperature and shipped on the same day or the next calendar day of collection.*

**A)** Write the patient name, and date of birth on the Red Top (without SST) vacutainer with permanent marker pen.



**A)** Complete all sections of the Test Request Form, including date of collection and payment type.

**B)** Place completed Test Request Form into the document holder outside of the specimen bag.


**A)** Perform blood draw to fill Red Top vacutainer.

**B)** Gently mix sample by inversion five times.\* **Keep sample at room temperature and ship the same day as collection.\*\***

*\* Do not shake.*

*\*\* Do not freeze or chill after collection to prevent hemolysis. Hemolyzed samples or delayed shipment will result in sample rejection.*

*The whole blood specimen in the vacutainer should ship the same day or the next calendar day of collection.*


**NOTE: DO NOT FREEZE OR REFRIGERATE WHOLE BLOOD (cold storage will result in whole blood hemolysis).**

**A)** Insert vacutainer containing blood sample *into* the foam tube holder.

**B)** Place the sample into the zip closure specimen bag and seal carefully. Keep specimen at room temperature\*

*\* DO NOT USE ICE PACKS — Do not freeze or chill collected sample.*

**On Day of Shipping:**

**A)** Place the specimen bag (*including the vacutainer with blood sample in the foam block, and the completed TRF*) inside the cardboard kit box.

**B)** Place the kit box in the supplied FedEx Clinical Pak and ship to Diagnostic Solutions Laboratory for testing.

Make note of your tracking number found on your shipping label.

**NOTE:** Please ensure that the shipping label is placed on the designated area, which is clearly marked on the middle of the FedEx Clinical Pak.

Place check mark in the square labeled "Exempt Human Specimen" on the back of the FedEx Clinical Pak.



**Do Not Freeze or Chill Collected Sample. Ship sample on the same day or the next calendar day of collection.**
